- a. Applications have been made available to all teachers that participated in a DSWCD education program

- c. Applications must be received by June 30, a winner will be approved at our July 3 planning meeting, and a plaque and cash prize will be presented at Anniversary event

15. 66th Anniversary Celebration – Josie Fuentes

- a. 369 Invitation have been sent, 17 RSVPs have come in via EventBrite
- b. Sponsors include Apple Rabbit Compost, Jacksonville Science Festival, NativeJax, Soil Life Organics and St. Johns Riverkeeper
- c. Checks received to date: Soil Life Organics (\$100), St. Johns Riverkeeper (\$100), Apple Rabbit Compost (\$100)
- d. Allen and Jennifer provide proposed agendas which are similar, so Josie and Jennifer will work on a program using those for approval at July 3 planning meeting

16. Sierra Club Joint Project Proposal – Jennifer Casey

- a. Postponed until Fall 2019
- James Cook suggests we contact Darren Gardner at 904-330-6070 with The Black Male College Explorers Program at Edward Waters College (high school intervention program) as a potential audience for this educational outreach event
- c. It is determined that the planned outreach is designed for elementary students, however an event with this group would be an excellent future outreach

17. Start Farming Panel – Jennifer Casey

- a. The main auditorium at the Extension office has been secured for the evening of Nov 5 and the event itself is scheduled for 5:30-7:30 p.m.
- b. Nathan Ballentine (the "Man in Overalls") and Jane Cant (UF/IFAS Small Farms Agent) have confirmed participation. Susan King (Atlantic Beach Urban Farms) has been invited. Caria Hawkins (Abundant Harvest Farm) regrets she is unable to participate due to schedule conflict.
- c. Jennifer will connect with SJC SWCD to discuss partnership and see if they would like to invite a SJC farmer to speak on the panel
- d. Other potential panelists to consider would be representatives from Down to Earth Farms or Congaree & Penn (both are past participants), Alvarez Farms, and Eugene Montgomery (NRCS cost-share program success)
- e. There will be no cost to table during the pop-up farmer's market and invitations to participate will go out soon. Allen recommends inviting the Farm Service Agency with USDA to table at the event.

20. District Funding – Allen Moore

- a. Allen states that there is a need to fund District activities as they were funded in the past with a COJ budget appropriation
- b. A similar appropriation could provide for a part-time District administrative secretary
- c. Allen thanks Josie Fuentes for her dedicated volunteer service, but suggests this should be a paid position
- d. James volunteers to speak in any capacity needed to make this argument on behalf of the board because projects need to be funded
- e. Jennifer suggests that grants can fund projects and that those grants could include administrative support for those projects. She states that while she supports applying for grants to fund the work of the District, she does not support a COJ budget appropriation request. She indicates that we have just begun to broaden our efforts to engage new volunteers and to add additional affiliate members to the board.
- f. Allen states that grants are only temporary sources of funding and he is thinking about the future and is considering a request in 2020

- b. Jennifer recommends that it be converted to a web-based form instead of paper copy

- a. Jennifer mentions concerns about sewage overflows from Wm Dunn provided by email. All members have not yet seen his concerns. Josie will provide members will copies of email thread provided by Wm Dunn for future discussion.
- b. Nathan Ballentine has provided by email information about membership in North Florida Green Chamber of Commerce for our review and consideration.
- c. Joshua Rosenberg (Candidate for Affiliate Membership) Joshua desires membership because he has a love for conservation. As the founder of NativeJax Permaculture Design he works in the field and wants to assist us in inspiring kids and encouraging conservation in the community. He has reviewed our unfunded 2018 urban permaculture grant application and has recommendations for future applications.
- d. Tiffany Bess (Candidate for Affiliate Membership) Tiffany is the founder of Apple Rabbit Compost, is involved with the Green Action Committee, serves on the Elements of MOSH board, the NFGCC Policy Board and the Community Compost Commission. She wants to help DSWCD build relationships and help us pursue opportunities to partner with organizations that have already been funded for conservation initiatives.
- e. Antoinette Jones (Candidate for Affiliate Membership) Antoinette is a full-time Watson Realtor and wants to help educate homebuyers about our natural resources as well as provide us with feedback and what citizens know and/or want to understand about our resources. She has strong sales and marketing experience, has hosted educational workshops with VyStar at local libraries, and has participated in Toastmasters. She provides a resume.
- f. Maria Machin Maria states that she volunteers with Lutheran Social services and suggests we consider a pop-up farmer's market and educational program to meet needs in communities with the newly-arrived to help them understand healthy food options
- g. Hampton Keith Hampton is an ACLU volunteer
- h. Rick Peterson Rick is the assistant manager for Jos A. Bank and is impressed with the work of the District and our meeting
