- 4. Partner Comments Geoff Sample, SJRWMD
  - a. Mr. Sample reports that January rainfall was above average and groundwater levels are high.
  - b. As one of 13 water conservation projects totaling \$1.2 million, SJRWMD has awarded Genuine Giant, LLC in Duval County \$198,735. Project is to install drain tile to augment existing tailwater recovery and addition of a surface water pump station for irrigation of rice, mayhaw trees, assorted fruits and vines, landscape nursery and hay.
  - c. SJRWMD requests help promoting current funding opportunities for Duval County. Response: If SJRWMD provides short description and a web link, DSWCD will promote this on our FB page.
