- 2021 Calendar Year Budget Reconciliation no update
- Treat Our Teachers event on Dec 7 12 teachers RSVP'd so far, there is a website page for teachers now, FB ad to be boosted.
- District Aide Thea Baker is moving. We need to advertise for new aide. Thea will wrap up remaining
 minutes and will participate virtually for a little bit into the new year.

Committee Reports:

- S-Line Regeneration Project
 - o Maternity leave 12/11-1/22
 - Collecting donations on website Paypal not set up yet, but there are instructions on how to give by check or money order.
 - Rotary Grant application Meetings scheduled with a couple of nonprofits for potential partnerships. Alison and Jennifer met with Kompan playground company at the site to get estimate for playground there which was app. \$69,000. COJ says that is low estimate for playgrounds based on others COJ has done. Also said, we are not obligated to use their vendors so will do more research.
 - UNF Intern 1/1-3/31 for 50-100 hrs. Alison creating and sending April her syllabus so she will know what to be working on during her internship with us.
 - Seed ceremony Saturday afternoon Josh needs to plant the seeds before he leaves town on Sunday. Seed choices for cover crops have been approved by COJ.
- Start Farming Panel Discussion & Holiday Market on Dec 1
 - Due to high sponsorship amounts (\$780) and hardships for farmers, Tiffany recommends honorariums of \$50 per panelist. Consensus reached to accommodate request.
 - Slight glitch on Eventbrite ticketing led us to go up to the next level of FB ad boosting. Jennifer recommends \$19 additional FB boost. Consensus reached to accommodate request.
 - Discussion about the enormous value that Tiffany brough to the event this year in organizing and also providing the zero-waste station. Honorarium of \$150 recommended and consensus reached to accommodate request.
